WAIVING OF UNION DUES WHILST ON UNPAID LEAVE

Union dues can be waived for the period of time that Unpaid Leave is taken from the Queensland Police Service. Members are required to complete the attached form applying to have their Union Dues waived, stating the commencement and return dates of Unpaid Leave. One of our elected officials will approve each members request and it will be processed accordingly.

**PLEASE NOTE: A letter or documentation from the Queensland Police Service
MUST BE ATTACHED verifying the dates of Unpaid Leave requested.**

QPUE Membership Rule 6.3.1 states:-

"A Member on leave without pay for a period of not less than three (3) months, is not liable to pay any membership fee, but the member is not entitled to any of the privileges of membership of the QPUE in respect to events which occur during such leave.

QPUE Membership Rule 6.3.2 states:-

A Member suspended without salary is liable to pay the Membership Fee.

QPUE Membership Rule 6.3.3. states:-

The onus shall be upon any Member returning to duty after leave without pay to notify the Union. Such Member shall be deemed unfinancial until all outstanding dues are paid.

MATERNITY LEAVE

QPUE Membership Rule 6.4 .1 states:-

Full membership fees are payable for the first 12 weeks. Part time membership fees are payable for any remaining paid leave.

QPUE Membership Rule 6.4.2 states:-

Where a member is working part time prior to commencing maternity leave part time membership fees will continue for all paid leave.

QPUE Membership Rule 6.4.3.

The onus shall be upon any Member returning to duty after maternity leave without pay to notify the Union. Such Member shall be deemed unfinancial until all outstanding dues are paid.
