### **Casual Vacancy Election**

Fair Work (Registered Organisations) Act 2009

**Nominations**, which must be in writing and comply with the registered rules of the Organisation, must be lodged at the meeting of the Branch Executive from 09:30 am Australian Eastern Daylight Time (AEDT) on Wednesday, 19 November 2025, until the close of nomination period, as per the AEC announcement at the meeting at Police Union Office, 217 North Quay, Brisbane.

**Please note,** a member of the electoral college who will not be in attendance at the Meeting, may advise the Returning Officer in writing, in advance of the Meeting, that they will stand as a candidate, and subject to their nomination being seconded by an attending Branch Executive Member, they will be a candidate in the election concerned. The nomination form must be lodged in the meeting.

Prospective candidates and nominators should verify their financial status and any other qualifications required by the Organisation's rules prior to lodging nominations.

**How to lodge nominations,** nominations must be lodged via the following method(s): **In-Person:** Before the nominations close at the meeting as announced by the Returning officer on 19 November 2025.

### Withdrawing Nominations

Nominations cannot be withdrawn after the close of nomination period at the meeting.

#### **Voting Period**

The ballot, if required, will open and close on Wednesday 19 November 2025 in the meeting held at Police Union Office, 217 North Quay, Brisbane. The Returning Officer will advise the opening and closing times of the ballot at the meeting.

#### **Proxy Voting**

A member of the college who is not present at the meeting may, in writing, appoint an **attending** Branch Executive Member to vote as their proxy. The appointment of the proxy must include the signature and name of the appointer and must be provided to the Returning Officer prior to 09:30 am Australian Eastern Daylight Time (AEDT) on Wednesday, 19 November 2025.

#### **Scrutineers**

A candidate may appoint a scrutineer. A form is available from the Returning Officer for the purposes of appointing Scrutineers.
